Tuition Rate Policy:

SECTION A: Registered & Supporting Members of St. John Vianney In-Parish Catholic Tuition Rate

In order to qualify, the family must meet the following criteria:

- Registered members of St. John Vianney Parish
- Regularly attend Mass on Saturday or Sundays and Holy days
- Participate in the Parish Stewardship of treasure, time and talent
- Complete the Stewardship Advancement Office Parish Verification Form and return it to the School Front Office

Parish envelopes must be used regularly throughout the year even if you are enrolled in and participating in the on-line giving program. The parish also values strongly the contributions of families who volunteer in various parish ministries. The Stewardship Advancement Office will review and approve the list of families eligible for the “in-parish” tuition rates once a year in January for the upcoming school year.

SECTION B: Registered/Non-Supporting Members of St. John Vianney/Other Catholic Parishes Tuition Rate

In order to qualify, the family must meet the following criteria:

- Complete the Stewardship Advancement Office Parish Verification Form & return it to the School Front Office (if Registered/Non-Supporting member of SJV) or their parish (if a member of another Catholic parish).
- If a member of another Catholic parish, the pastor must sign the form, verifying the family is a registered member of that parish. Each parish has its own criteria to determine if a family is registered.
- Return the approved form to the School Front Office

If the Stewardship Advancement Office Parish Verification Form is not received, the family is assessed the Unregistered Catholic Families/Non-Catholic Families rate (Section C). Family status is re-evaluated once a year. Families will be notified by letter if their status will be changed. If the family feels their status was changed in error, they must write a letter to the Stewardship Advancement Office explaining how they meet the criteria for either Section A or Section B tuition rates.

ALL families must sign up with FACTS Tuition Management Company for tuition processing.

****In the 2017-2018 Academic year, any family receiving a government scholarship (Step-Up for Students, AAA, PLSAP, McKay), will not be eligible for the multi-student discount.**
